Announcement of Receiving the ZEB Certifications for JRE Yoyogi 1Chome Building and JRE Kayabacho 2Chome Building

Japan Real Estate Investment Corporation ("JRE") hereby announces that JRE Yoyogi 1Chome Building and JRE Kayabacho 2Chome Building, properties it owns, have received a ZEB (Note1) Oriented (Note2) Certification and a ZEB Ready Certification respectively. Additionally, both of them also received "5 Stars", the highest certification rank by the Building-Housing Energy-efficiency Labeling System ("BELS"). They are the third and fourth ZEB certified buildings in its portfolio, and this is the first time JRE has obtained a ZEB Oriented Certification.

(Note1) A ZEB (Zero Energy Building) is a building that aims at net zero energy balance, which is evaluated in the BELS certification system in 4 stages, ZEB, Nearly ZEB, ZEB Ready, and ZEB Oriented.

(Note2) ZEB Oriented is a certification category newly established in 2019 for large-scale buildings with a gross floor area of 10,000m² or more that are considered difficult to convert to ZEBs. For office buildings, the certification requires reducing primary energy consumption by 40% or more compared to the reference building, as well as adopting a promising but still untested technology that significantly contributes to energy conservation.

The above evaluations are based on the design and renovation plan for each of the buildings, assuming that the renovations will be carried out in the future. We will determine the actual timing of the renovation works considering the long-term renovation plans for the entire portfolio.

JRE has obtained the ZEB Ready Certifications with the advice of engineering experts. We will continue our efforts to realize ZEBs through renovations for other existing properties.
